Depending on the number of teams signing up, each team will play 3-5 games against various opponents. There will also be food and raffle prizes for all participants. All funds raised through registration and raffles will be donated to Big Brothers Big Sisters of Guelph.

If we were to receive the \$500 PDR, it would cover the majority of our expenses, allowing more proceeds to go to Big Brothers Big Sisters of Guelph. Upon receiving this funding, we will consider lowering the registration costs per team and supply food for participants (rather than selling it), ultimately making the event more financially accessible for participating students. We are also encouraging PSOs to use PDR funding to 'sponsor' teams who wish to sign up, with the potential of each residence sending a team or two.
